The cost for an expedited evaluation is an additional \$200. Personal checks are not accepted. Evaluations must be paid for by an attorney check, money order, a cashier check or credit card. Additional original reports of work experience evaluations are \$50.00 each and will be issued up to one year from the issuance of the original report.
